



Divergent Discourses on Roman Colonization

SIGONIUS, LIPSIUS, AND THE DEVELOPMENT OF ROMAN COLONIAL STUDIES

In late sixteenth-century antiquarian scholarship, two very different views on Roman colonization were developed that greatly influenced the study and understanding of Roman colonialism and imperial strategy ever since. On the one hand, the Italian scholar Carolus Sigonius (1520-1584) meticulously analyzed Roman republican colonization as a vehicle of social emancipation and agrarian reform. On the other, the position exemplified by the Dutch scholar Justus Lipsius (1547-1606) presented Roman colonization as a laudable model of attaining military and cultural hegemony. These two divergent perspectives have been adopted and adapted in different practical and ideological contexts, from European colonialism in the Americas to modern theories of Roman imperial strategy, private property and state formation.
